INVITATION FOR NEGOTIATED PROCUREMENT

Waterproofing, Repainting of Exterior Walls, Termite Control, Rewiring of Vault Lighting including Replacement of Lighting Fixtures at the Registry of Deeds building of Quirino, Cabarroguis

- 1. In view of the two (2) failed public bidding, the Land Registration Authority (LRA) through its Bids and Awards Committee (BAC) invites interested bidders to participate in the Negotiated Procurement for the "Waterproofing, Repainting of Exterior Walls, Termite Control, Rewiring of Vault Lighting including Replacement of Lighting Fixtures at the Registry of Deeds building of Quirino, Cabarroguis" in accordance with Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Act." The Approved Budget for the Contract (ABC) is in PHILIPPINE PESO: FOUR HUNDRED SEVEN THOUSAND SIX HUNDRED NINETEEN and 08/100 CENTAVOS (PHP 407,619.08)
- 2. The following eligibility and technical documents as well as the Financial Proposal/Quotation Form (Form "A") shall be submitted on or before **28 December 2022**, **8:00 A.M.** at the LRA-BAC Office, **4**th Floor, LRA Building:
 - Certified true copy of current Mayor's / Business Permit;
 - 2. PhilGEPS Registration Certificate;
 - 3. Certified true copy of PCAB License;
 - 4. Income / Business Tax Return;
 - 5. Omnibus Sworn Statement (Form "C");
 - 6. Affidavit of Site Inspection; and
 - 7. List of Completed and on-going Contracts (Form "B")

Details on this project may refer to Scope of Work and Specifications (Annex "A")

Completion of the works is required within Forty-Five (45) working days from commencement date.

- 3. A complete set of Scope of Work, Form "A", Form "B", Form "C" and shop Drawing (Annex "B") may be purchased by interested contractors at the LRA-BAC Office, 4th floor, LRA Building corner NIA Road, Diliman, Quezon City.
- 4. Only interested bidders / contractors who paid the fee in a non-refundable amount of PHILIPPINE PESO: FIVE HUNDRED (PHP 500.00) shall have their best and final offer opened. Best and final offers received in excess of the ABC shall be automatically rejected.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 5. The LRA-BAC shall conduct the meeting for the opening of the Eligibility Documents, Technical Proposal, and Best and Final Offer on 28 December 2022, 9:00 A.M. at the LRA conference room, 4th floor. Authorized attendees including the representatives of bidders may join via video conferencing, bit.ly/2022NP RDCabarroguis and/or face-to-face meeting at the conference room. Late bids shall not be accepted.

SCOPE OF WORKS

- 1. Mobilization/De-Mobilization of personnel, materials, equipments, provision of temporary facilities and utilities and upon completion cleaning of work the area and disposal of waste materials and debris as to leave premises in perfect condition, accepted by LRA.
- 2. De clogging of existing roof drains and downspout, clearing, grubbing, disposal of waste materials.
- 3. Removal of existing waterproofing and concrete covering/topping.
- 4. Application of waterproofing membrane (5years warranty) on vault Roof Deck.
- 5. Removal of exterior painting of the building. (surface preparation)
- 6. Re-painting of exterior walls of the building. Use Boysen or approved equal.
- 7. Application of termite control (Comprehensive termite control Chemical Method).
 - A. Scope of service warranty:
 - Perimeter cordoning Termiticide is injected into soil immediately surrounding the target structure thru 20mm holes at 0.5 to 1.0 meter intervals.
 - Surface spray application.
 - Wood drenching Treatment on components susceptible to termite attach such as door jambs, partition, dividers and ceiling woodworks.
 - B. Schedule of visits: (For one (1) year warranty)
 - Initial treatment as agreed by the contractor and LRA
 - 2nd monitoring visit Six (6) months after initial treatment
 - 3rd monitoring visit twelve (12) months after initial treatment
- 8. Rewiring of vault lightings. Use EMT pipe and 3.5 mm² THHN wire.
- 9. Replacement of lighting fixtures including lamp. USE LED lamp.
- 10. Application of vulcaseal/sealant on roofing.
- 11. All items mentioned above subject for inspection and approval of LRA before installation.
- 12. Site visit is required.
