I. Issues and Concerns

1. Mr. Mc Edwin P. Montañes of Philcare Manpower Services, inquired if there is a prescribed format for the submission of bid form, statement of all its ongoing government and private contracts, and statement of Single Largest Completed Contract (SLCC).

ANSWER: The body opted to use prescribed format for the submission of bid form, statement of all its ongoing government and private contracts, and statement of Single Largest Completed Contract (SLCC), attached as Annex "A".

2. Ms. Jobelle Pulido of Omniworx Inc., clarified the basis of agency fee/administrative fee. She asked whether this Authority follows the 10% agency fee imposed by the DOLE.

ANSWER: The body answered that under subparagraph no.3 (3), Section VI Schedule of Requirements of the bidding documents, it is expressly stated that "In relation to agency fee, there shall be no lower limit of floor on the amount of the award pursuant to Section 31, Rule IX of Republic Act No.9184 and its 2016 Revised Implementing Rules and Regulation and the applicable GPPB Resolutions or other related issuance.
