LRA BAC-PGSM RESOLUTION NO. 2022-45

(Pursuant to Approved Annual Procurement Plan for FY 2022)

A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF DOCUMENTARY BOXES, DATA FOLDERS 14", DATA FOLDERS 19", DATA FOLDERS SPANISH 22", PLASTIC ENVELOPES AND VERTICAL FOLDERS (1 LOT)

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee on the Procurement of Goods, Supplies and Materials (BAC-PGSM), pursuant to the provision of Republic Act No. 9184, as amended, posted and Invitation to Bid on the LRA and Philippine Government Electronic Procurement System (PHILGEPS) websites on September 23, 2022, and conspicuous place reserved for this purpose in the premises of this Authority for the Supply and Delivery of Documentary Boxes, Data Folders 14", Data Folders 19", Data Folders Spanish 22", Plastic Envelopes and Vertical Folders (1 Lot), with an Approved Budget for the Contract (ABC) in the amount of Six Million Nine Hundred Thirty-nine Thousand Six Hundred Thirty-four Pesos (₱6,939,634.00);

WHEREAS, only one (1) bidder, Center Point Sales and Trading Inc. purchased bid documents and submitted the required documents for bidding on the date fixed in the bidding document;

WHEREAS, at 10:00 am, on 14 October 2022, the BAC-PGSM conducted the opening and preliminary examination of the bid duly submitted by the sole bidder, Center Point Sales and Trading Inc. It was declared "eligible" by the BAC-PGSM, using the legally recognized "Pass or Fail" criteria, for having submitted the complete eligibility documents and complying with the specifications as indicated in Section VII of the bidding documents. Thus, its financial proposal was opened. It submitted a bid amounting to Six Million Nine Hundred Thirty-nine Thousand Six Hundred Thirty-four Pesos (₱6,939,634.00), inclusive of VAT, an offer which is within the ABC (See Evaluation Data Sheet, attached as Annex "A")

WHEREAS, after the BAC-PGSM's declaration of the Center Point Sales and Trading Incorporated's offer as the Single Calculated Bid, a post qualification evaluation was conducted on November 02, 2022 by the Technical Working Group and BAC-Secretariat to verify and validate whether said bidder has passed all the requirements and conditions as specified in the bidding documents.

A Resolution Declaring The Single Calculated And Responsive Bid (SCRB) And Recommending The Award Of Contract For The Supply And Delivery Of Documentary Boxes, Data Folders 14", Data Folders 19", Data Folders Spanish 22", Plastic Envelopes And Vertical Folders (1 Lot) WHEREAS, after the said post qualification evaluation, the Center Point Sales and Trading Incorporated's offer was determined to be the Single Calculated and Responsive Bid for having complied with the requirements of the BAC-PGSM and finding the same to be in full accord with the provisions of the pertinent procurement law for the said procurement activity (See TWG Post Qualification Report, attached as Annex "B")

WHEREAS, the BAC-PGSM finds the recommendation of the BAC-Technical Working Group in strict accordance with R.A No. 9184 and its Revised IRR.

NOW, **THEREFORE**, We the Members of the Bids and Award Committee on the Procurement of Goods, Supplies and Materials (BAC-PGSM), RESOLVED, to:

- 1. DECLARE Center Point Sales and Trading Incorporated to be the Single Calculated and Responsive Bid (SCRB) and;
- 2. RECOMMEND to the Honorable Administrator through this instrument that Center Point Sales and Trading Incorporated be awarded the contract for the Supply and Delivery of Documentary Boxes, Data Folders 14", Data Folders 19", Data Folders Spanish 22", Plastic Envelopes and Vertical Folders (1 Lot) in the amount of Six Million Nine Hundred Thirty-nine Thousand Six hundred Thirty-four Pesos (\$\mathbb{P}6,939,634.00)\$, VAT Inclusive.
