(Pursuant to BAC-PGSM Reso. No. 2022-31)

**DECLARING CCP COMPUTER TECHNOLOGIES, INC., AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE PROCUREMENT OF THE SUPPLY AND DELIVERY OF TONER CARTRIDGES FOR HP DESIGN T1600 PRINTER AND RECOMMEND THE AWARD OF CONTRACT THEREFOR**

**WHEREAS**, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed ₱1,000,000.00, commenced the procurement for the **Supply and Delivery of Toner Cartridges for HP Design T1600 Printer** with an Approved Budget for the Contract (ABC) in the amount of Three Hundred Sixty-eight Thousand Pesos (**₱368,000.00**), VAT inclusive;

**WHEREAS**, on 13 December 2022, the LRA-BAC submitted Request for Quotation for the said procurement project to three (3) prospective bidders. The same is posted on the LRA and PhilGEPS websites;

**WHEREAS**, before the deadline on 16 December 2022, **Pronet Systems Integrated Network Solutions, Inc., and CCP Computer Technologies, Inc.**, submitted their respective quotations in a sealed envelope within the deadline;

**WHEREAS**, during the meeting conducted on 19 December 2022, at the LRA Conference Room, the LRA-BAC opened the quotations of the above-mentioned bidder which was found to have full compliance to all technical specification, as well as financial specification as shown in the table below:

**WHEREAS**, per evaluation of the BAC-TWG for Non-Infra, the two (2) bidders passed the eligibility and technical requirements. The offer of CCP Computer Technologies, Inc., amounting to **Two Hundred Forty-six Thousand Two Hundred Forty Pesos (₱246,240.00) VAT Inclusive**, is deemed to be the most advantageous to the government as the same is the Lowest Calculated and Responsive Quotation (LCRQ);

**WHEREAS**, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra is in strict accordance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

**NOW, THEREFORE**, We, the members of the LRA-BAC hereby RESOLVE to:

- 1) DECLARE the quotation of **CCP Computer Technologies, Inc.**, as the Lowest Calculated and Responsive Quotation (LCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Procurement of **Supply and Delivery of Toner Cartridges for HP Design T1600 Printer** to **CCP Computer Technologies, Inc.**, in the amount of **Two Hundred Forty-six Thousand Two Hundred Forty Pesos (₱246,240.00) VAT Inclusive.**
