**DECLARING DEPENDABLE PACKAGING AND PRINTING HOUSE CORPORATION AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) FOR THE SUPPLY AND DELIVERY OF MAILING ENVELOPES AND RECOMMEND THE AWARD OF CONTRACT THEREFOR**

**WHEREAS**, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed ₱1,000,000.00, commenced the procurement for the **Supply and Delivery of Mailing Envelopes with an ABC in the amount of Four Hundred Eighteen Thousand Four Hundred Pesos (₱418,400.00)**, VAT inclusive which is included in the LRA Annual Procurement Plan for FY 2022;

**WHEREAS**, on 29 November 2022, the LRA-BAC submitted Request for Quotation for the said procurement project to three (3) prospective bidders. The same is posted on the LRA and PhilGEPS websites on 29 November 2022;

**WHEREAS**, before the deadline on 05 December 2022 at 4:00 pm, Dependable Packaging and Printing House Corporation, and Centurian International Corporation submitted their respective quotation in a sealed envelope within the deadline;

**WHEREAS**, during the meeting conducted on 13 December 2022 at the LRA Conference Room, the LRA-BAC opened the quotations from the two aforementioned bidders which was found to have the full compliance to all technical specification, as well as financial specification as shown in the table below:
