## LRA BAC-PGSM RESOLUTION No. 2022-32

WHEREAS, on 23 September 2022, the Bids and Awards Committee on the Procurement of Goods, Supplies, and Materials (BAC-PGSM) proceeded to open the quotations duly submitted by bidders in response to the Request for Quotation (RFQ) for LRA's Small Value Procurement for the Supply and Delivery of Yearly Subscription of 500 Antivirus Software Licenses for Server, Desktop & Laptop Computers with an Approved Budget for the Contract (ABC) in the amount of Six Hundred Forty Four Thousand Pesos (PHP 644,000.00).

WHEREAS, the BAC-PGSM Technical Working Group (TWG) proceeded to evaluate the two (2) quotations submitted by Onprem2cloud IT Solutions, Co. and Infobahn Communications, Inc.

WHEREAS, the bid price quoted by Onprem2cloud IT Solutions, Co. and Infobahn Communications, Inc. are as follows:

**WHEREAS**, the **TWG** has determined that only one (1) of the said quotations is compliant with and responsive to all the requirements and conditions specified in the **RFQ** (see attached TWG Evaluation Report).

WHEREAS, Onprem2cloud IT Solutions, Co. has submitted the lowest quotation in the amount of Three Hundred Ninety Nine Thousand Nine Hundred Ninety Pesos (Php 399,990.00) which is within the Approved Budget for the Contract (ABC). But unfortunately, it was disqualified due to noncompliance to at least one of the requirement specifications.

WHEREAS, Infobahn Communications, Inc. has submitted the next lowest quotation in the amount of Six Hundred Thirty Eight Thousand Pesos (Php 638,000.00) which is within the Approved Budget for the Contract (ABC).

WHEREAS, the TWG has recommended that the quotation by Infobahn Communications, Inc. be declared the Lowest Calculated and Responsive Quotation (LCRQ) and that the Award of Contract be given to said bidder.

**WHEREAS,** the BAC-PGSM finds the recommendation of the BAC-TWG is in strict accordance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

**WHEREAS,** Section 12 of R.A. No. 9184 mandated that the BAC-PGSM shall recommend the award of contract to the Head of the Procuring Entity or his/hers duly authorized representative;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee on the Procurement of Goods, Supplies and Materials (BAC-PGSM), RESOLVE, as it is hereby RESOLVED, the following:

- 1) to DECLARE the quotation by **Infobahn Communications, Inc.** as the Lowest Calculated and Responsive Quotation (LCRQ); and
- to RECOMMEND to the Honorable Administrator the Award of Contract for the Procurement of Supply and Delivery of Yearly Subscription of 500 Antivirus Software Licenses for Server, Desktop & Laptop Computers to **Infobahn Communications, Inc.** in the amount of Six Hundred Thirty Eight Thousand Pesos (Php 638,000.00).
