LRA BAC-PGSM RESOLUTION No. 2022-49

(Pursuant to Supplemental Procurement Program ICT-2022-04)

Declaring INFOBAHN COMMUNICATIONS, INC., as the Single Calculated and Responsive Quotation (SCRQ) to LRA's Small Value Procurement for the Renewal of Fortigate-200D Unified Unified Threat Management Bundle from November 24, 2022 to May 22, 2023 and Recommend the Award of Contract therefor

WHEREAS, the Land Registration Authority, through the Bids and Award Committee on the Procurement of Goods, Supplies and Materials (BAC-PGSM), pursuant to the provision under Item No. 8, Annex H of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184e which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed Php1,000,000.00, commenced the procurement for the Renewal of Fortigate-200D Unified Unified Threat Management Bundle from November 24, 2022 to May 22, 2023 (Annex A) with an Approved Budget for the Contract (ABC) in the amount of One Hundred Thousand Pesos (Php 100,000.00) VAT Inclusive, which is included in the LRA Supplemental Procurement Plan (SPP) ICT-2022-04 for FY 2022 (Annex B);

WHEREAS, on 6 November 2022, the BAC-PGSM posted in the Philippine Government Electronic Procurement System (PHILGEPS) website the Request for Quotation (RFQ) for the said procurement project. The said document was posted as well in the LRA website on 7 November 2022.

WHEREAS, Infobahn Communications, Inc., was the only supplier which submitted its quotation in sealed envelope before the deadline set at 4:00 PM, on 11 November 2022, at the office of the BAC-PGSM Secretariat, the time, date, and place specified in the Request for Quotation (RFQ);

WHEREAS, during the meeting conducted on 16 November 2022 at the LRA Conference Room, the quotation of the lone supplier was opened and the BAC-PGSM ascertained the existence of all the documents required using a non-discretionary "pass / fail" criterion;

WHEREAS, per evaluation of the BAC-PGSM Technical Working Group (TWG), the documents submitted by **Infobahn Communications**, **Inc.** passed the eligibility and technical requirements. Its offer amounting to Php 95,000.00 (VAT Inclusive) is deemed to be the most advantageous to the government as the same is the single calculated and responsive quotation (Annex C);

WHEREAS, the BAC-PGSM Members finds the recommendation of the BAC-PGSM TWG in strict compliance with RA 9184 and its revised IRR.
