LRA BAC-PGSM RESOLUTION No. 2022-52

(Pursuant to LRA BAC-PGSM RESOLUTION No. 2022-47)

AWARDING THE SUPPLY AND DELIVERY OF VARIOUS KYOCERA TONERS TO PHILCOPY CORPORATION

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), commenced the procurement for the Supply and Delivery of Various Kyocera Toners with an Approved Budget for the Contract (ABC) in the amount of Six Million Six Hundred Eighty-Six Thousand Nine Hundred Pesos (\$\frac{1}{2}6,686,900.00)\$, VAT inclusive;

WHEREAS, the LRA-BAC, held a meeting on 19 December 2022, respecting supply and delivery of various kyocera toners via direct contracting;

WHEREAS, a LRA BAC-PGSM Resolution No.2022-47 was signed thereon which sought to purchase the following supplies to Philopy Corporation, to wit:

1. Toner Cartridges (TK-1175)	500 Cartridges
2. Toner Cartridges (TK-6113)	175 Cartridges
3. Toner Cartridges (TK-6329)	80 Cartridges

WHEREAS, pursuant to the procurement, a Request for Quotation (RFQ) was sent to Philopy Corporation, to which they complied by sending on or before 22 December 2022 the rates for the above-mentioned kyocera toners;

WHEREAS, the BAC has determined on 20 December 2022, after checking their envelopes, that the prospective distributor is compliant with the requirements set by the BAC, in concurrence with Section 50 of Republic Act No. 9184, viz:

Section 50. Direct Contracting. - Direct Contracting may be resorted to only in any of the following conditions:

- c. Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the BAC-PGSM, hereby RESOLVE to:

RECOMMEND to the Honorable Administrator, through this instrument that the procurement of various kyocera toners be awarded to Philcopy Corporation in the amount of Six Million Six Hundred Eighty-six Thousand Nine Hundred Pesos (\$\pi\$6,686,900.00), VAT Inclusive;
