- Delivery of Purified Drinking Water twice a week
- Sanitary permit/s for the duration of the contract
- 900 bottles per month
- Submission of microbiological water test laboratory certificate and quarterly submission thereof from water testing laboratory accredited by the DOH and FDA
- One (1) on-call technician to repair defective water dispenser
