2. Pre-Bid Conference shall be held on June 29, 2023, 10:00 o'clock in the morning, at the Conference Room, 4<sup>th</sup> Floor, LRA Building, East Avenue corner NIA Road, Quezon City.
3. Sealed proposals in triplicate shall be received on July 06, 2023, 09:00 AM, at the Conference Room, 4<sup>th</sup> Floor, LRA Building, East Avenue, corner NIA Road, Quezon City, after which, the said proposals shall be opened in the presence of attending bidders and COA Representative.
4. Unserviceable motor vehicles shall be sold on an **"AS IS, WHERE IS BASIS, INCLUSIVE OF PULL-OUT COST"**.
5. Bidders are required to conduct a thorough inspection of the unserviceable motor vehicles and must consider all attendant problems and difficulties when preparing their bids.
6. If the bidder who submitted the best offer refuses to push through with the purchase of said motor vehicles, his/her bid security shall be forfeited and the same shall be awarded to the second highest bidder.
7. Sale shall be on a **PER LOT BASIS**.
