



LRA-SPECIAL BAC RESOLUTION NO. 2023-02
(Pursuant to Supplemental Procurement Program ICT-2023-06)

**DECLARING INTEGRATED COMPUTER SYSTEMS, INC. AS THE
SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR THE
SUPPLY, DELIVERY, AND INSTALLATION OF ONE (1) UNIT
DATA STORAGE**

WHEREAS, the Land Registration Authority, through the Special Bids and Awards Committee (LRA-SPBAC), pursuant to the provision of Republic Act No. 9184, invited bidders through posting in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 21 September 2023, for the **Supply, Delivery, and Installation of One (1) Unit Data Storage** with an ABC in the amount of **THREE MILLION SEVEN HUNDRED THOUSAND PESOS (PHP 3,700,000.00), VAT Inclusive;**

WHEREAS, the Pre-Bid Conference was conducted on 29 September 2023 at the LRA Conference Room with the following prospective bidders: 1) Digi-Specs I.T. Corp.; 2) Apsys Solution; 3) Integrated Computer Systems, Inc.; 4) Infobahn Communications, Inc.; 5) Questech Co., Inc.; and 6) Pronet Integrated Network Solutions, Inc;

WHEREAS, only **Integrated Computer Systems, Inc.** purchased the bid documents;

WHEREAS, before the 13 October 2023 deadline, only one (1) sealed envelope from Integrated Computer Systems, Inc. was received by the LRA-SPBAC Secretariat;

WHEREAS, the sole sealed envelope was then opened and presented during the LRA-SPBAC meeting, called for the purpose, on 13 October 2023 at the LRA Conference Room;

WHEREAS, per the preliminary evaluation of the LRA-SPBAC Technical Working Group (TWG), the sole bidder, **Integrated Computer Systems, Inc.**, passed the eligibility requirements;

WHEREAS, **Integrated Computer Systems, Inc.** submitted the sole bid amounting to **TWO MILLION SIX HUNDRED EIGHTY FOUR THOUSAND THREE HUNDRED PESOS (PHP 2,684,300.00), VAT inclusive**, which is within the ABC;

WHEREAS, the LRA-SPBAC TWG proceeded with the detailed evaluation and, on 19 and 20 October 2023, the post qualification was conducted;

WHEREAS, on 23 October 2023, the LRA-SPBAC TWG reported that **Integrated Computer Systems, Inc.** passed the technical and financial requirements as well as the criteria for post qualification;

WHEREAS, the offer of **Integrated Computer Systems, Inc.** is deemed to be the most advantageous to the government as the same is the Single Calculated and Responsive Bid (SCRB);

WHEREAS, the LRA-SPBAC finds the recommendation of the LRA-SPBAC TWG in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW THEREFORE, We, the members of the LRA-SPBAC, hereby RESOLVE to:

1. DECLARE the bid of **Integrated Computer Systems, Inc.** as the Single Calculated and Responsive Bid (SCRB); and
2. RECOMMEND to the Honorable Administrator the Award of Contract for the **Supply, Delivery, and Installation of One (1) Unit Data Storage** to **Integrated Computer Systems, Inc.** with a submitted bid price amounting to **TWO MILLION SIX HUNDRED EIGHTY FOUR THOUSAND THREE HUNDRED PESOS (PHP 2,684,300.00), VAT inclusive.**
