This Bid Bulletin is hereby issued to all prospective bidders, for their information and guidance, on the submission of their respective proposals for the Supply and Delivery of 10 units of Geographical Information System (GIS) Workstations -**High-End Desktop Computers.**

These changes, revisions, modifications or clarifications shall become an integral part of the Contract and Bidding Documents and shall be taken into account in the submission of the prospective bidders' sealed proposals.

Issues and concerns raised by the Prospective bidders through their written ١. queries were as follows:

Integrated Computer System, Inc. (ICS)

1. Would you consider relaxing the USB-a 3.2 Gen 2 port for at least Two (2x) only? Rest assured that we will comply with the required number of USB-A ports.

ANSWER: We will not relax the USB specification since we will be transferring large files.

2. Would you consider relaxing the refresh rate of monitors for at least 75Hz since not all brands that offer a 100Hz or higher for their commercial monitor? Usually higher hertz are commonly found on gaming monitors.

ANSWER: No, we will be using multiple layers of map on the GIS and we will require 100Hz.

3. For the standard conformity, may we confirm if the standard is pertaining to EN/IEC 62040-1 & 2 instead of EN/IEC 60204-1 & 2 (UPS).

ANSWER: The correct standard for UPS is EN/IEC 62040-1.

Advance Solutions, Inc.

1. May we request to consider relaxing the monitor refresh rate from 100 Hz to at least 75 Hz. This aligns with the monitor business standards for the brand we are offering, which typically range from 60 to 70 Hz.

ANSWER: No, we will be using multiple layers of map on the GIS and we will





require 100Hz.
