**RESOLUTION DECLARING A FAILURE OF PROCUREMENT FOR THE
SUPPLY AND DELIVERY OF TOKENS FOR STAKEHOLDERS**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act (R.A.) No. 9184, as amended, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **SUPPLY AND DELIVERY OF TOKENS FOR STAKEHOLDERS** with an Approved Budget for the Contract (ABC) in the amount of **NINE HUNDRED EIGHTY THOUSAND PESOS ONLY (PHP 980,000.00), VAT Inclusive;**

WHEREAS, Section 35, Sub-section 35.1 of the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184 provides the following;

Section 35. Failure of Bidding

35.1. The BAC shall declare the bidding a failure when:

a) No bids are received;

WHEREAS, in compliance with the aforesaid provision in the IRR of R.A. No. 9184, the LRA-BAC finds it proper to declare a failure of bidding for the **Supply and Delivery of Tokens for Stakeholders;**

NOW, THEREFORE, We, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE a failure of bidding for the **Supply and Delivery of Tokens for Stakeholders;** and
- 2) RECOMMEND the reposting of the Request for Quotation (RFQ) of the aforementioned procurement project.
