(Pursuant to Approved Supplemental Procurement Program (2023-1S))

RESOLUTION DECLARING A FAILURE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF 120 CARTRIDGE HP INK 682 TRI-COLOR AND HP 682 BLACK

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act (R.A.) No. 9184, as amended, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the SUPPLY AND DELIVERY OF 120 CARTRIDGE HP INK 682 TRI-COLOR AND HP 682 BLACK with an Approved Budget for the Contract (ABC) in the amount of SIXTY-ONE THOUSAND EIGHT HUNDRED PESOS ONLY (PHP 61,800.00), VAT Inclusive:

WHEREAS, the Request for Quotation (RFQ) for the procurement was posted on the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 24 November 2023;

WHEREAS, the said RFQ was sent to at least three (3) prospective bidders;

WHEREAS, when the deadline for submission of bids lapsed on 28 November 2023 at 4:00 p.m., two (2) sealed quotations were received by the BAC Secretariat for Non-Infra, to wit: 1) Integrated Computer Systems, Inc. and 2) Group 5 Computer Products & Supplies, Inc.;

WHEREAS, on 29 November 2023, the sealed envelopes were consecutively presented and opened in a BAC Meeting called for the purpose;

WHEREAS, during the Opening of Quotations, it was found that the Request for Quotation (RFQ) posted in the PhilGEPS and LRA websites does not require the submission of the notarized Omnibus Sworn Statement;

WHEREAS, Annex "H" of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 requires the submission of the notarized Omnibus Sworn Statement for all Small Value Procurement with an ABC of more than FIFTY THOUSAND PESOS (PHP 50,000.00);

WHEREAS, Section 41(b) of the 2016 Revised IRR of R.A. No. 9184 provides that the Head of Procuring Entity (HoPE) reserves the right to declare a failure of bidding, to wit:

Section 41. Reservation Clause

The HoPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in the following situations:

b) If the BAC is found to have failed in following the prescribed bidding procedures; and

c) xxx.

WHEREAS, in compliance with the aforesaid provision in the IRR of R.A. No. 9184, the LRA-BAC finds it proper to declare a failure of bidding for the Supply and Delivery of 120 Cartridge HP INK 682 Tri-Color and HP 682 Black;

NOW, THEREFORE, We, the members of the LRA-BAC, hereby RESOLVE to:

- DECLARE a failure of bidding for the procurement of SUPPLY AND DELIVERY OF 120 CARTRIDGE HP INK 682 TRI-COLOR AND HP 682 BLACK; and
- 2) RECOMMEND the reposting of the revised Request for Quotation, requiring the submission of the notarized Omnibus Sworn Statement, for the aforesaid procurement project.

On 24 November 2023, the LRA-BAC submitted a Request for Quotation for LRA's Small Value Procurement for the Supply and Delivery of 120 Cartridge HP INK 682 Tri-Color and HP 682 Black with an Approved Budget for the Contract (ABC) in the amount of SIXTY-ONE THOUSAND EIGHT HUNDRED PESOS ONLY (PHP 61,800.00), VAT Inclusive, to at least three (3) prospective bidders.

On 28 November 2023, the deadline for submission of bids for the Supply and Delivery of 120 Cartridge HP INK 682 Tri-Color and HP 682 Black, two (2) sealed quotations were received by the BAC Secretariat for Non-Infra, to wit: 1) Integrated Computer Systems, Inc. and 2) Group 5 Computer Products & Supplies, Inc.
