This Bid Bulletin is hereby issued to all prospective bidders, for their information and guidance, on the submission of their respective proposals for the **Design and Construction of Registries of Deeds Building of Lamut Ifugao**, **Infanta Quezon**, **and Isulan**, **Sultan Kudarat (3 Lots)**.

These changes, revisions, modifications or clarifications shall become an integral part of the Contract and Bidding Documents and shall be taken into account in the submission of the prospective bidders' sealed proposals.



- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
