LRA-SPECIAL BAC RESOLUTION NO. 2023-07

(Pursuant to Supplemental Procurement Program ICT-2023-10)

DECLARING NUNTIUS ELECTRONICS INC. AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION (SCRQ) FOR THE SUPPLY AND DELIVERY OF ELEVEN (11) UNITS OF LAPTOP COMPUTER AND ONE (1) UNIT OF MULTI-FUNCTION COLORED PRINTER WITH AUTOMATIC DOCUMENT FEEDER (ADF) & REFILLABLE LIQUID INK TANK (1 LOT)

WHEREAS, the Land Registration Authority, through the Special Bids and Awards Committee (LRA-SPBAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the Supply and Delivery of Eleven (11) Units of Laptop Computer and One (1) Unit of Multi-function Colored Printer with Automatic Document Feeder (ADF) & Refillable Liquid Ink Tank (1 Lot), with an ABC in the amount of NINE HUNDRED NINETY NINE THOUSAND FIVE HUNDRED (P999,500.00), VAT inclusive:

WHEREAS, the LRA-SPBAC submitted a Request for Quotation for the aforesaid procurement project to at least three (3) prospective suppliers and the same was posted on the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 14 December 2023;

WHEREAS, before the 18 December 2023 deadline, three prospective suppliers namely, (1) DCI Int'l IT Solution and Services Corporation, (2) Nuntius Electronics, Inc., and (3) Accessories and Supplies Depot, Inc., submitted their quotations in sealed envelopes to the LRA-SPBAC Secretariat:

WHEREAS, the sealed envelopes were then opened and presented during the LRA-SPBAC meeting, called for the purpose, on 18 December 2023 at the LRA Conference Room;

WHEREAS, in the course of the evaluation of the quotations submitted, the following results were obtained:

WHEREAS, per evaluation of the Technical Working Group (SPBAC-TWG), only **Nuntius Electronics Inc.** is in full compliance with all the eligibility, technical, and documentary requirements;

WHEREAS, the SPBAC-TWG recommended that Nuntius Electronics Inc. be declared as the Single Calculated and Responsive Quotation (SCRQ) with a price quotation amounting to Eight Hundred Nineteen Thousand Pesos Only (PHP 819,000.00), VAT inclusive, which is within the ABC;

WHEREAS, the LRA-SPBAC finds the recommendation of the LRA-SPBAC TWG in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW THEREFORE, We, the members of the LRA-SPBAC, hereby RESOLVE to:

- 1. DECLARE the quotation of NUNTIUS ELECTRONICS INC. as the Single Calculated and Responsive Quotation (SCRQ) for the Supply and Delivery of Eleven (11) Units of Laptop Computer and One (1) Unit of Multi-function Colored Printer with Automatic Document Feeder (ADF) & Refillable Liquid Ink Tank (1 Lot), in the amount of Eight Hundred Nineteen Thousand Pesos Only (PHP 819,000.00), VAT inclusive;
- 2. RECOMMEND the Award of Contract for the procurement of Supply and Delivery of Eleven (11) Units of Laptop Computer and One (1) Unit of Multi-function Colored Printer with Automatic Document Feeder (ADF) & Refillable Liquid Ink Tank (1 Lot) in the amount of Eight Hundred Nineteen Thousand Pesos Only (PHP 819,000.00), VAT inclusive.
