**LRA BAC-PGSM RESOLUTION NO. 2023-94**

(Pursuant to Supplemental Procurement Plan ICT-2023-05)

**DECLARING INTEGRATED COMPUTER SYSTEMS, INC. AS THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF 70 SETS OF COLORED TONER CARTRIDGES (BLACK, CYAN, YELLOW AND MAGENTA) FOR HP LASER JET PRO MFP M280NW COLORED PRINTERS**

**WHEREAS**, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, as amended, invited bidders through posting in Philippine Government Electronic Procurement System (PhilGEPS) and LRA websites on 14 September 2023, for the **Supply and Delivery of 70 sets of Colored Toner Cartridges (Black, Cyan, Yellow and Magenta) for HP Laser Jet Pro MFP M280nw Colored Printers**, with an Approved Budget for the Contract (ABC) in the amount of **One Million Six Hundred Nineteen Thousand Eight Hundred Pesos (Php1,619,800.00)**, VAT inclusive;

**WHEREAS**, on 22 September 2023 at 03:00 PM, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiries that the bidders may have, it was attended by one (1) prospective bidder, to wit: **Quartz Business Products Corporation**.

**WHEREAS**, three (3) prospective bidders purchased the bid documents to wit: **DCI Int'l I.T. Solutions & Services Corp., Quartz Business Products Corp. and Integrated Computer System Incorporate**.

**WHEREAS**, before the 05 October 2023 deadline, three (3) sealed envelopes were received by the BAC-Secretariat for Non-Infra, to wit: **DCI Int'l I.T. Solutions & Services Corp., Quartz Business Products Corp. and Integrated Computer System Incorporated**.

**WHEREAS**, the three (3) sealed envelopes were consecutively opened and presented during the LRA-BAC meeting, called for the purpose, on 05 October 2023, 3:00 PM, at the LRA Conference Room;

**WHEREAS**, per evaluation of the BAC-TWG for Non-Infra, the three (3) bidders were in full compliance with all the eligibility and technical components and financial component;

**WHEREAS**, the three (3) compliant bidders submitted the following bid:

**WHEREAS**, among the three (3) compliant bidders, **Integrated Computer Systems, Inc.** submitted the lowest bid price amounting to **One Million One Hundred Seven Thousand One Hundred Twenty Pesos Only (PhP1,107,120.00)**, VAT inclusive, which is within the ABC.


**WHEREAS**, **Integrated Computer Systems, Inc.** was determined as the Lowest Calculated Bidder (LCB) and was scheduled for post-qualification evaluation last 16 October 2023;

**WHEREAS**, on 16 October 2023, the BAC TWG for Non-Infra conducted a post-qualification on **Integrated Computer Systems, Inc.** to determine compliance and responsiveness of its bid. Its post-qualification report dated 25 October 2023 (Annex A), recommended that the bid submitted by **Integrated Computer Systems, Inc.** be declared as the Lowest Calculated and Responsive Bid (LCRB);

**NOW, THEREFORE**, for and in consideration of the foregoing. We, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE the bid of **Integrated Computer Systems, Inc.** as the **Lowest Calculated and Responsive Bid (LCRB)**; and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the **Supply and Delivery of 70 sets of Colored Toner Cartridges (Black, Cyan, Yellow and Magenta) for HP Laser Jet Pro MFP M280nw Colored Printers**, to **Integrated Computer Systems, Inc.** with a submitted bid price amounting to **One Million One Hundred Seven Thousand One Hundred Twenty Pesos Only (PhP1,107,120.00)**, VAT inclusive.
