**AWARDING THE SUPPLY AND DELIVERY OF SRT PANEL/ COLOR RIBBON
AND RETRANSFER FILM FOR EDISECURE XID PRINTER TO AZITSOROG
INCORPORATED VIA DIRECT CONTRACTING**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, Section 48, Rule XVI Alternative Methods of Procurement of the revised Implementing Rules and Regulation (IRR) of Republic Act (R.A.) 9184, otherwise known as the Government Procurement Reform Act provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;

WHEREAS, LRA BAC-PGSM Resolution No. 2023-42 was signed thereon to purchase the following supplies to Azitsorog Incorporated via Direct Contracting, to wit:

1. 2 rolls, SRT Panel/Color Ribbon with an approved budget for the contract of Php 55,800.00 at Php 27,900.00 per roll;
2. 5 rolls, Retransfer Film for EDIsecure XID Printer with an approved budget for the contract of Php 44,750.00 at Php 8,950.00 per roll;

WHEREAS, on 05 September 2023, the LRA-BAC submitted a Request for Quotation (**Direct Contracting**) for the **Supply and Delivery of SRT Panel/Color Ribbon and Retransfer Film for EDIsecure XID Printer** with an Approved Budget for the Contract (ABC) in the amount of **One Hundred Thousand Five Hundred Fifty Pesos Only (Php 100,550.00)**, VAT Inclusive, to **Azitsorog Incorporated**.

WHEREAS, the said procurement was posted in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites.

WHEREAS, on the 08 September 2023 deadline, a sealed envelope from **Azitsorog Incorporated** was received by the BAC-Secretariat for Non-Infra. The sealed envelope was opened and presented during the BAC meeting, called for the purpose, on 12 September 2023 at the LRA Conference Room.
