LRA BAC-PGSM RESOLUTION NO. 2023-130
(Pursuant to Supplemental Procurement Program SPP- 09)

DECLARING DEUS ENTERPRISES CO. AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE PROCUREMENT OF CATERING SERVICE/ PACKED MEALS FOR YEAR END ASSESSMENT AND CHRISTMAS PARTY ON 15 DECEMBER 2023

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **Procurement of Catering Service/Packed Meals for Year End Assessment and Christmas Party on 15 December 2023** with a total ABC amount of **Nine Hundred Eighty-Five Thousand Pesos Only (Php 985,000.00) VAT Inclusive;**

WHEREAS, the said procurement was posted in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 24 November 2023;

WHEREAS, before the 28 November 2023 deadline, Three (3) sealed envelope was received by the BAC-Secretariat for Non-Infra;

WHEREAS, the three (3) sealed envelopes were opened and presented during the LRA-BAC meeting called for the purpose, on 29 November 2023 at the LRA Conference Room;

WHEREAS, **Deus Enterprises Co.**, and **NIA Central Office Multipurpose Cooperative** passed the eligibility requirements but **Peri-Peri Charcoal Chicken Sauce Bar** failed to submit their Photocopy of Income/Business Tax Return;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, **Deus Enterprises Co.** and **NIA Central Office Multipurpose Cooperative** were able to comply with the necessary documentary requirements and technical specifications required.

WHEREAS, **Deus Enterprises Co.** submitted a quotation amounting to **Eight Hundred Ninety-Seven Thousand Five Hundred Pesos Only (Php 897,500.00)**, VAT inclusive, which is within the Approved Budget for the Contract (ABC).

WHEREAS, the offer of **Deus Enterprises Co.** is deemed to be the most advantageous to the government as the same is the **Lowest Calculated and Responsive Quotation (LCRQ);**

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;
