DECLARING DEGTEK INFORMATION TECHNOLOGY SOLUTIONS AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE PROCUREMENT OF ZOOM VIDEOCONFERENCING APPLICATION

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the Zoom Videoconferencing Application with an ABC in the amount of One Hundred Sixty-Eight Thousand Pesos (Php 168,000.00), VAT Inclusive;

WHEREAS, the said procurement was posted on the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 27 April 2023;

WHEREAS, before the 03 May 2023 deadline, six (6) sealed envelopes were received by the BAC-Secretariat for Non-Infra.

WHEREAS, the six (6) sealed envelopes were consecutively opened and presented during the LRA-BAC meeting, called for the purpose, on 12 May 2023 at the LRA Conference Room.

WHEREAS, the six (6) bidders submitted the following quotations:
