DECLARING INNOVALITE INC. AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY & DELIVERY OF 30 UNITS OF ELECTRIC FAN (CEILING)

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, as amended, invited suppliers through sending the request for quotation to at least three (3) suppliers of known qualification for the Procurement of **Supply & Delivery of 30 Units of Electric Fan (Ceiling)**, via Small Value Procurement, with an ABC in the amount of **Thirty-Six Thousand Six Hundred Sixty Pesos (Php36,660.00)**, VAT inclusive;

WHEREAS, before the 15 September 2023 deadline, only one (1) sealed envelope from Innovalite Inc. was received by the BAC-Secretariat for Non-Infra;

WHEREAS, the quotation submitted by Innovalite Inc. was opened and presented during the LRA-BAC meeting, called for the purpose, on 22 September 2023 at the LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, the quotation submitted by Innovalite Inc. was found to have full compliance with all technical specifications, as well as financial specifications;

WHEREAS, the single compliant bidder submitted the following quotation:

WHEREAS, Innovalite Inc. submitted the sole quotation amounting to **Thirty-Six Thousand Six Hundred Sixty Pesos (Php36,660.00)**, VAT inclusive, which is within the ABC.

WHEREAS, the offer of **Innovalite Inc.** is deemed to be the most advantageous to the government as the same is the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;




