LRA BAC-PGSM RESOLUTION NO. 2023-54
(Pursuant to Supplemental Procurement Program HRDD 2023-02)

**DECLARING IRENTRADE INDUSTRIAL SALES AND SERVICES AS THE
LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY
AND DELIVERY OF ONE THOUSAND (1,000) PIECES OF ID LACE**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, as amended, invited suppliers through posting in Philippine Government Electronic Procurement System (PHILGEPS), and by sending the request for quotation to at least three (3) suppliers of known qualification for the Procurement of **Supply and Delivery of One Thousand (1,000) Pieces Of ID Lace**, via Small Value Procurement, **with an Approved Budget for the Contract in the amount of Fifty Thousand Pesos (Php 50,000.00)**, VAT inclusive, which is included in the LRA Supplemental Procurement Program (SPP) (HRDD 2023-02) (Annex A);

WHEREAS, under Item No. 8, Annex H of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed Php1,000,000.00;

WHEREAS, on 19 August 2023, the LRA-BAC posted in the PhilGEPS and LRA website the Request for Quotation (RFQ) for the said procurement project. The BAC-PGSM also invited the following suppliers to submit their respective quotations/proposals; (1) **Azitorsog Incorporated**, (2) **Irentrade Industrial Sales & Services**; and (3) **Work Habits Trading** (Annex B);

WHEREAS, (1) **Azitorsog Incorporated** and (2) **Irentrade Industrial Sales & Services**, submitted their quotation in a sealed envelope within the deadline set at 4:00 PM, on 23 August 2023;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, the two (2) bidders namely ; (1) **Azitorsog Incorporated** and (2) **Irentrade Industrial Sales & Services**, passed the eligibility requirements. The offer of **Irentrade Industrial Sales & Services** amounting to **Forty Seven Thousand Pesos (Php 47,000.00)** VAT Inclusive, is deemed to be the most advantageous to the government as the same is the Lowest Calculated and Responsive Quotation (LCRQ) as shown in the table:

- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Procurement of **Supply and Delivery Of One Thousand (1,000) pieces of ID Lace** in the amount of **Forty Seven Thousand Pesos (Php 47,000.00)**, VAT Inclusive.

RESOLVED this 15th day of September 2023 at the Land Registration Authority, Quezon City.


