LRA BAC-PGSM RESOLUTION NO. 2023-131
(Pursuant to Supplemental Procurement Program SPP- 09)

DECLARING ONLINE CLOTHING ENT. AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND DELIVERY OF JACKETS FOR LRA OFFICIALS

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **Procurement of Supply and Delivery of Jackets for LRA Officials** with a total ABC amount of **Four Hundred Thirty-Five Thousand Pesos Only (Php 435,000.00) VAT Inclusive**;

WHEREAS, the said procurement was posted on the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 24 November 2023;

WHEREAS, before the 28 November 2023 deadline, only one (1) sealed envelope from **Online Clothing Ent.** was received by the BAC-Secretariat for Non-Infra;

WHEREAS, the quotation submitted by **Online Clothing Ent.** was opened and presented during the LRA-BAC meeting called for the purpose on 29 November 2023 at the LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, **Online Clothing Ent.** was able to comply with the necessary documentary requirements and technical specifications required;

WHEREAS, **Online Clothing Ent.** submitted a quotation amounting to **Two Hundred Thousand Eighty-Five Pesos and 50/100 (Php 200,085.50) VAT inclusive**, which is within the ABC;

WHEREAS, the offer of **Online Clothing Ent.** is deemed to be the most advantageous to the government as the same is the **Single Calculated and Responsive Quotation (SCRQ)**;

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing. We, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE the quotation of **Online Clothing Ent.** as the Single Calculated and Responsive Quotation (SCRQ); and



- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the **Procurement of Supply and Delivery of Jackets for LRA Officials** to **Online Clothing Ent.** with a submitted bid price amounting to **Two Hundred Thousand Eighty-Five Pesos and 50/100 (Php 200,085.50) VAT Inclusive.**


