DECLARING LEVEL GROUNDS EVENTS MANAGEMENT SERVICES AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE RENTAL OF LED WALL, LIGHTS AND SOUND SYSTEM FOR THE LRA CENTRAL OFFICE 2023 YEAR-END PARTY

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **Rental of LED Wall, Lights and Sound System for the LRA Central Office 2023 Year-End Party** with a total ABC amount of **One Hundred Thirty Thousand Pesos Only (Php 130,000.00), VAT Inclusive;**

WHEREAS, the said procurement was posted in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 05 December 2023;

WHEREAS, before the deadline on 08 December 2023, at 12:00 noon, One (1) sealed envelope was received by the BAC-Secretariat for Non-Infra;

WHEREAS, the sealed envelope was opened and presented during the LRA-BAC meeting called for the purpose, on 11 December 2023 at the LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, **Level Grounds Events Management Services** was able to comply with the necessary documentary requirements and technical specifications required.

WHEREAS, **Level Grounds Events Management Services** submitted a quotation amounting to **One Hundred Thirty Thousand Pesos Only (Php 130,000.00)**, VAT inclusive, which is equal to the Approved Budget for the Contract (ABC).

WHEREAS, the offer of **Level Grounds Events Management Services** is deemed to be the most advantageous to the government as the same is the **Single Calculated and Responsive Quotation (SCRQ);**

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing. We, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE the quotation of **Level Grounds Events Management Services** as the Single Calculated and Responsive Quotation (SCRQ); and
