(Pursuant to Approved Supplemental Procurement Plan SPP-07)

**DECLARING CENTURIAN INTERNATIONAL CORPORATION
AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE
SUPPLY & DELIVERY OF LRA MAILING ENVELOPE**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php1,000,000.00, commenced the procurement for the **Supply & Delivery of LRA Mailing Envelope** with an ABC in the amount of **Seventy Thousand Pesos (Php70,000.00), VAT Inclusive**;

WHEREAS, the said procurement was posted in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 27 September 2023;

WHEREAS, before the 04 October 2023 deadline, one (1) sealed envelope was received by the BAC-Secretariat for Non-Infra;

WHEREAS, the one (1) sealed envelope was opened and presented during the LRA-BAC meeting, called for the purpose, on 05 October 2023 at the LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, the lone (1) bidder was able to comply with the necessary documentary requirements and technical specifications required;

WHEREAS, **Centurian International Corporation** submitted a quotation amounting to **Forty-six Thousand Eight Hundred Pesos (Php46,800.00)**, VAT inclusive, which is within the Approved Budget for the Contract (ABC).

WHEREAS, the offer of **Centurian International Corporation** is deemed to be the most advantageous to the government as the same is the **Single Calculated and Responsive Quotation (SCRQ)**;

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, We, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE the quotation of **Centurian International Corporation** as the Single Calculated and Responsive Quotation (SCRQ); and
