**RESOLUTION DECLARING A FAILURE OF PROCUREMENT FOR THE  
RENTAL OF OUTDOOR TENT FOR LRA CENTRAL OFFICE 2023 YEAR-END  
PARTY.**

**WHEREAS**, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **RENTAL OF OUTDOOR TENT FOR LRA CENTRAL OFFICE 2023 YEAR-END PARTY**, with an Approved Budget for the Contract (ABC) in the amount of **Fifty Thousand Pesos Only (Php 50,000.00), VAT Inclusive**;

**WHEREAS**, the Request for Quotation (RFQ) was sent to three (3) prospective bidders;

**WHEREAS**, the deadline for submission of bids was on or before 28 November 2023, 04:00 p.m., as specified in the RFQ;

**WHEREAS**, until said deadline, no bids were received by the BAC Secretariat;

**WHEREAS**, Section 35 and 35.1 of the 2016 Revised IRR of R.A 9184 is hereby quoted as follows:

Section 35 of the 2016 IRR of RA 9184 provides that:

“Section 35. Failure of Bidding

35.1. The BAC shall declare the bidding a failure when:

a) No bids are received x x x “

**NOW, THEREFORE**, We, the members of the LRA-BAC, hereby RESOLVE to:

1. Declare a failure of bidding for the **Rental Of Outdoor Tent for LRA Central Office 2023 Year-End Party**; and
2. Conduct a reposting of Request for Quotation therefor.
