**A RESOLUTION RECOMMENDING THE EXTENSION OF THE DELIVERY
PERIOD RELATIVE TO ITEMS OF P.O. NO. S-003-01-2023 DATED
JANUARY 27, 2023**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), has determined that the said procurement can be facilitated under the terms of Small Value Procurement, which method is provided for in Section 53.9 of the 2016 Revised Implementing Rules and Regulations of RA No. 9184;

WHEREAS, on January 25, 2023, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), issued LRA BAC-PGSM Resolution No. 2023-06 declaring Responsive Quotation (SCRQ) for the Supply and Delivery of LRA Paperweight with 3D Print;

WHEREAS, on January 25, 2023, Notice of Award was issued in favor of Steelcare Enterprises Corporation by this Authority;

WHEREAS, based on the Terms and Conditions stated in the Request for Quotation (RFQ) the delivery period shall be on January 31, 2023;

WHEREAS, despite the diligent effort and even considering that the BAC has already substantially undertaken the procurement activities, the Notice to Proceed was issued only on January 27, 2023;

WHEREAS, on January 31, 2023, the LRA-BAC received a letter from Mr. Higinio C. Sy, President, Steelcare Enterprises Corporation, requesting for an extension of delivery;

WHEREAS, due to the volume of paperweight to be produced and the limited time given to the supplier it is no longer feasible for the supplier to meet the deadline. Therefore, we find this reason meritorious.

NOW, THEREFORE, We, the members of the LRA-BAC hereby RESOLVE to:

RECOMMEND to this Authority's Head of the Procuring Entity (HOPE), **Hon. Gerardo Pangga Sirios**, Administrator or his duly authorized representative, the extension of the original delivery date of January 31, 2023 to March 2, 2023, in as much as the justification therefore appears to be meritorious and that such slight delay in delivery does not in any manner prejudice the interests of the government.
