



LRA BAC-PGSM RESOLUTION NO. 2023-21

(Pursuant to Approved Supplemental Procurement Program 2023-03)

**DECLARING TRIPLE RG CONSUMER GOODS TRADING AS THE SINGLE
CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND
DELIVERY OF 175 UNITS OF MONOBLOC CHAIRS**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee, pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed ₱1,000,000.00, commenced the procurement for the **Supply and Delivery of 175 Units of Monobloc Chairs** with an ABC in the amount of **One Hundred Six Thousand Nine Hundred Twenty-Five Pesos (₱106,925.00)**, VAT inclusive;

WHEREAS, on 12 May 2023, the LRA-BAC submitted a Request for Quotation for the said procurement project to three (3) prospective bidders. The same is posted on the LRA and PhilGEPS websites on 12 May 2023;

WHEREAS, before the deadline on 16 May 2023 at 4:00 PM, (1) **MKS Furniture**; (2) **Center Point Sales & Trading**; (3) **Triple RG Consumer Goods Trading**; (4) **Luxenberg Marketing Inc.**, (5) **Tarlac Mac Enterprises, Inc.**, (6) **Don Jay Enterprises**, submitted their respective quotations within the deadline;

WHEREAS, during the meeting conducted on 17 May 2023 at 10:00 AM, at the LRA Financial Service Conference Room, the LRA-BAC checked the quotations of the above-mentioned bidder;

WHEREAS, Center Point Sales & Trading, Inc., and Don Jay Enterprises were disqualified for submitting Omnibus Sworn Statement, that were not notarized, and MKS Furniture, Luxenberg Marketing, Inc., and Tarlac Mac Enterprises, Inc., were all disqualified for failing to meet the technical specification. Only **Triple RG Consumer Goods Trading** passed the eligibility and technical requirements.

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, We, the members of the LRA-BAC hereby RESOLVE to:

- 1) DECLARE the quotation of **Triple RG Consumer Goods Trading** as the Single Calculated and Responsive Quotation (SCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Procurement of **Supply and Delivery of 175 Units of Monobloc Chairs** with an ABC in the amount of **Ninety-Four Thousand Five Hundred Pesos (₱94,500.00)**, VAT Inclusive.


