



LRA BAC-PGSM RESOLUTION NO. 2023-05
(Pursuant to Supplemental Procurement Plan for FY 2023)

**DECLARING ONLINE CLOTHING ENTERPRISES AS THE LOWEST
CALCULATED AND RESPONSIVE QUOTATION FOR THE PROCUREMENT
OF POLO SHIRTS (120TH LRA ANNIVERSARY)**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, as amended, invited suppliers through posting in Philippine Government Electronic Procurement System (PHILGEPS), and by sending the request for quotation to at least three (3) suppliers of known qualification for the **Procurement of Polo Shirts (120th LRA Anniversary)**, via Small Value Procurement, with an ABC in the amount of **Nine Hundred Ninety-Two Thousand One Hundred Forty Five Pesos (P992,145.00)**, VAT inclusive; which is included in the LRA Supplemental Procurement Plan (SPP) for FY 2023 (Annex A);

WHEREAS, under Item No. 8, Annex H of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed Php1,000,000.00;

WHEREAS, on 18 January 2023, the LRA-BAC posted in the PhilGEPS and LRA website the Request for Quotation (RFQ) for the said procurement project. The BAC-PGSM also invited the following suppliers to submit their respective quotations/proposals; 1.) Zioneyes General Merchandise; 2.) Arty Arty by Speedy Merchandising Corp.; and 3.) VJ Graphics Arts, Inc. (Annex B);

WHEREAS, before the deadline on 23 January 2023 at 8:00 AM, (1) **Grafiq Advertising System Corporation**, (2) **Jimbes Printing Company**, (3) **Avecilla Trading**, (4) **Gameville Corporation**, (5) **Arty Arty by Speedy Merchandising Corporation**, and (6) **Online Clothing Enterprises** submitted their respective quotations within the deadline;

WHEREAS, during the meeting conducted on 23 January 2023 at 9:30 AM, at the LRA Conference Room, the LRA-BAC checked the quotations of the above-mentioned bidder;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, **Grafiq Advertising System Corporation**, **Jimbes Printing Company**, **Avecilla Trading**, **Gameville Corporation**, and **Online Clothing Enterprises** passed the eligibility and technical requirements, while **Arty Arty by Speedy Merchandising Corporation** was disqualified for non-submission of notarized omnibus sworn statement. The offer of **Online Clothing Enterprises** amounting to **Five Hundred Seven Thousand Six Hundred Sixty-Nine Pesos**

(P507,669.00) VAT Inclusive, is deemed to be the most advantageous to the government as the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;


NOW, THEREFORE, We, the members of the LRA-BAC hereby RESOLVE to:

- 1) DECLARE the quotation of **Online Clothing Enterprises** as the Lowest Calculated and Responsive Quotation (LCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the **Procurement of Polo Shirts (120th LRA Anniversary)** in the amount of **Five Hundred Seven Thousand Six Hundred Sixty-Nine Pesos (P507,669.00)** VAT Inclusive.


