DECLARING EBIZOLUTION INC. AS THE SINGLE AND HIGHEST RATED BID (HRB) FOR THE CONSULTING SERVICES FOR THE SYSTEM DEVELOPMENT OF THE PERSONAL PROPERTY SECURITY REGISTRY (PPSR)

WHEREAS, the Land Registration Authority, through the Special Bids and Awards Committee (LRA-SPBAC), pursuant to the provision of Republic Act No. 9184, invited bidders through posting in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 30 January 2024, for the Consulting Services for the System Development of the Personal Property Security Registry (PPSR) with an Approved Budget for the Contract (ABC) in the amount of TWELVE MILLION PESOS (PHP 12,000,000.00), VAT Inclusive;

WHEREAS, the deadline for submission of eligibility documents is 07 February 2024 on or before 9:30 AM;

WHEREAS, before the 07 February 2024 deadline, two (2) prospective bidders, namely: (1) Beacon Solutions, Inc.; and (2) Ebizolution, Inc., submitted their eligibility requirements in sealed envelopes to the LRA-SPBAC Secretariat for eligibility checking;

WHEREAS, the sealed envelopes were then opened and presented during the LRA-SPBAC meeting, called for the purpose, on 07 February 2024 at the LRA Conference Room;

WHEREAS, per preliminary evaluation of the LRA-SPBAC Technical Working Group (TWG) using a non-discretionary "pass / fail" criterion as stated in the Request for Expression of Interest, all prospective bidders are in full compliance with the eligibility requirements set by LRA-SPBAC;

WHEREAS, the LRA-SPBAC TWG conducted the detailed evaluation of the eligibility documents submitted by the two (2) prospective bidders and, as per said detailed evaluation, the SPBAC-TWG found that both prospective bidders complied with the eligibility requirements;

WHEREAS, on 08 February 2024, the LRA- SPBAC TWG conducted the Assessment for Shortlisting of the prospective bidders using the following criteria:
