Upon the award of the design and build contract, the winning bidder shall be responsible for the preparation and submission of all necessary detailed engineering investigations, surveys and design in Annex "A" of the IRR of RA 9184 **within 90 days from the receipt of the Notice to Proceed.**

Corollary, contract signing shall be done upon submission of the required *performance security*.
