(Pursuant to Approved Supplemental Procurement Plan for FY 2024)

DECLARING JEWEL CRAFTERS OPC AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY & DELIVERY OF COLLAR PIN FOR SERVICE AWARDEES

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, as amended, invited suppliers through sending the request for quotation to at least three (3) suppliers of known qualification for the Procurement of Supply & Delivery of Collar Pin for Service Awardees, via Small Value Procurement, with an ABC in the amount of Fifty-Eight Thousand Pesos (Php 58,000.00), VAT inclusive;

WHEREAS, before 08:00 AM, 23 January 2024 deadline, only one (1) sealed envelope from **Jewel Crafters OPC** was received by the BAC-Secretariat for Non-Infra;

WHEREAS, the quotation submitted by Jewel Crafters OPC was opened and presented during the LRA-BAC meeting, called for the purpose, on 23 January 2024, 9:00 AM at the LRA Finance Service Conference Room;

WHEREAS, the BAC Technical Working Group (TWG) proceeded to evaluate the quotation from the aforementioned supplier and noticed the discrepancy between the amount in words versus the amount in figures of the financial bid, reflected as follows:

- Amount in Words: Fifty-Two Thousand Pesos Only
- Amount in Figures: Php 52,500.00

WHEREAS, in such circumstances, Section 32.2.3 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

"In case of discrepancies between: (a) bid prices in figures and in words, the latter shall prevail;..."

WHEREAS, the BAC-TWG invoked the policy wherein the amount in words shall prevail, to which the bid amount submitted by the Jewel Crafters OPC shall be Fifty-Two Thousand Pesos Only (Php 52,000.00).

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, the quotation submitted by Jewel Crafters OPC was found to have full compliance with all technical specifications, as well as financial specifications;

WHEREAS, the offer of Jewel Crafters OPC is deemed to be the most advantageous to the government as the same is the Single Calculated and Responsive Quotation (SCRQ);



WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, we, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE the quotation of **Jewel Crafters OPC** as the Single Calculated and Responsive Quotation (SCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Supply and Delivery of Collar Pin for Service Awardees to Jewel Crafters OPC with a submitted bid price amounting to Fifty-Two Thousand Pesos (Php 52,000.00), VAT inclusive.
