(Pursuant to Annual Procurement Plan Non CSE For FY 2024)

**DECLARING ONLINE CLOTHING ENTERPRISES AS THE SINGLE
CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND
DELIVERY OF POLO SHIRT (LRA WOMEN'S MONTH CELEBRATION)**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed PHP 1,000,000.00, commenced the **Supply and Delivery of Polo Shirt (LRA Women's Month Celebration)** with an Approved Budget for the Contract (ABC) in the amount of **Two Hundred Thirty-Eight Thousand Four Hundred Pesos Only (PHP 238,400.00), VAT Inclusive;**

WHEREAS, the said procurement was posted in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 23 February 2024;

WHEREAS, before the deadline on 26 February 2024, at 8:00 AM, one (1) sealed envelope from Online Clothing Enterprises was received by the BAC-Secretariat for Non-Infra;

WHEREAS, the sealed envelope was opened and presented during the LRA-BAC meeting called for the purpose, on 26 February 2024 at the LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, **Online Clothing Enterprises** was able to comply with all the necessary documentary requirements and technical specifications required;

WHEREAS, **Online Clothing Enterprises** submitted a quotation amounting to **Two Hundred Thirty-Eight Thousand Four Hundred Pesos Only (PHP 238,400.00)**, VAT inclusive, which is equal to the ABC;

WHEREAS, the offer of **Online Clothing Enterprises** is deemed to be the most advantageous to the government as the same is the **Single Calculated and Responsive Quotation (SCRQ)**;

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing. We, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE the quotation of **Online Clothing Enterprises** as the Single Calculated and Responsive Quotation (SCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the **Supply and Delivery of Polo Shirt (LRA Women's Month Celebration)** with a submitted bid price amounting to **Two Hundred Thirty-Eight Thousand Four Hundred Pesos Only (PHP 238,400.00)**, VAT Inclusive.
