**LRA BAC-PGSM RESOLUTION NO. 2024-06**

(Pursuant to Approved Supplemental Procurement Plan for FY 2024)

**DECLARING LEVEL GROUNDS EVENTS MANAGEMENT SERVICES AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE RENTAL OF LED WALL, LIGHTS AND SOUND SYSTEM FOR THE LRA 121ST ANNIVERSARY**

**WHEREAS**, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, as amended, invited suppliers through sending the request for quotation to at least three (3) suppliers of known qualification for the **Rental of LED Wall, Lights and Sound System for the LRA 121st Anniversary**, via Small Value Procurement, with an ABC in the amount of **One Hundred Fifty Thousand Pesos (Php 150,000.00)**, VAT inclusive;

**WHEREAS**, before 08:00 AM, 26 January 2024 deadline, three (3) sealed envelopes from **CSG Events Management Services, Level Grounds Events Management Services, and Artjohnley Enterprises** were received by the BAC-Secretariat for Non-Infra;

**WHEREAS**, the quotations submitted by the three (3) aforementioned bidders were opened and presented during the LRA-BAC meeting, called for the purpose, on 26 January 2024, 9:00 AM at the LRA Conference Room;

**WHEREAS**, upon evaluation, only the quotation submitted by **Level Grounds Events Management Services** passed all the eligibility requirements, the quotations submitted by **CSG Events Management Services**, and **Artjohnley Enterprises** were declared "failed". **CSG Events Management Services** failed for non-submission of Mayor's Permit, while **Artjohnley Enterprises** failed for non-submission of notarized Omnibus Sworn Statement.

**WHEREAS**, **Level Grounds Events Management Services** submitted a price quotation in the amount of **One Hundred Forty-Five Thousand Pesos (Php 145,000.00)**, VAT Inclusive, which is within the ABC.

**WHEREAS**, the offer of **Level Grounds Events Management Services** is deemed to be the most advantageous to the government as the same is the Single Calculated and Responsive Quotation (SCRQ);

**WHEREAS**, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

**NOW, THEREFORE**, for and in consideration of the foregoing, we, the members of the LRA-BAC, hereby RESOLVE to:

- 1) DECLARE the quotation of **Level Grounds Events Management Services** as the Single Calculated and Responsive Quotation (SCRQ); and




