**DECLARING BESCOST DIGITAL MARKETING SERVICES AS THE SINGLE
CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND
DELIVERY OF SIX (6) UNITS OF PARKING SIGNAGES**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **Supply and Delivery of Six (6) Units of Parking Signages** with an ABC in the amount of **Forty-One Thousand Six Hundred Pesos Only (Php 41,600.00)**, VAT Inclusive;

WHEREAS, the said procurement was posted in the LRA website on 12 March 2024;

WHEREAS, the Request for Quotation (RFQ) was sent to three (3) prospective bidders;

WHEREAS, the deadline for submission of bids was on or before 15 March 2024, 04:00 PM, as specified in the Request for Quotation;

WHEREAS, before the deadline, only one bidder, **Bescost Digital Marketing Services** submitted its quotation;

WHEREAS, on 19 March 2024, the quotation submitted by **Bescost Digital Marketing Services** was opened and presented;

WHEREAS, the BAC-Technical Working Group (TWG) evaluated the lone quotation and found it to be compliant with all financial and technical specifications;

WHEREAS, **Bescost Digital Marketing Services** submitted a quotation amounting to **Forty-One Thousand Six Hundred Pesos Only (Php 41,600.00)**, VAT inclusive, which is the same with the ABC;

WHEREAS, the offer of **Bescost Digital Marketing Services** is deemed to be the most advantageous to the government as the same is the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;
