



LRA BAC INFRASTRUCTURE RESOLUTION NO. 2024-01

**DECLARING MDQR CONSTRUCTION AND SUPPLY AS THE
LOWEST CALCULATED AND RESPONSIVE QUOTATION (LCRQ)
TO LRA'S SMALL VALUE PROCUREMENT FOR THE REPAIR/
REFURBISHMENT OF BROKEN GLASS WINDOWS AND
REPLACEMENT OF BROKEN BRONZE GLASS OF VARIOUS
OFFICES AT LRA CO BUILDING**

WHEREAS, on 11 March 2024, the LRA Bids and Awards Committee for Infrastructure (LRA-BAC INFRA) proceeded to open the quotations duly submitted by bidder in response to the Request for Quotation (RFQ) for the **Repair/Refurbishment of Broken Glass Windows and Replacement of Broken Bronze Glass of Various Offices at LRA CO Building**, with an Approved Budget for the Contract (ABC) in the amount of **THREE HUNDRED ELEVEN THOUSAND FOUR HUNDRED PESOS (Php 311,400.00), VAT inclusive**;

WHEREAS, the LRA-BAC INFRA posted the Request for Quotation for the aforesaid procurement project on the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 01 March 2024;

WHEREAS, before the 08 March 2024 deadline, three (3) prospective contractors namely, (1) DGFF Builders and (2) MDQR Construction and Supply (3) Marvel Builders submitted their quotations in sealed envelopes to the LRA-BAC INFRA Secretariat;

WHEREAS, the sealed envelopes were then opened and presented during the LRA-BAC INFRA meeting, called for the purpose, on 11 March 2024 at the LRA Conference Room;

WHEREAS, the bidders, submitted and passed the preliminary examination on eligibility requirements, the following results were obtained:

For failure of Marvel Builders to indicate the procurement project in the OSS as Procurement for the Repair/Refurbishment of Broken Glass Windows and Replacement of Broken Bronze Glass of Various Offices at LRA Central Office Building, it is deemed disqualified from the Request for Quotation.	-

WHEREAS, MDQR CONSTRUCTION AND SUPPLY was determined by the TWG to be the LCRQ;

WHEREAS, the LRA-BAC INFRA finds the recommendation of the TWG in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW THEREFORE, for and in consideration of the foregoing, the Chairperson and Members of the LRA-BAC INFRA, RESOLVE as it is hereby RESOLVED to:

1. DECLARE the quotation of MDQR CONSTRUCTION AND SUPPLY as the **LCRQ** for the **Procurement for the Repair/ Refurbishment of Broken Glass Windows and Replacement of Broken Bronze Glass of Various Offices at LRA CO Building**, in the amount of **THREE HUNDRED SIX THOUSAND AND ONE HUNDRED PESOS ONLY (Php 306,100.00)**;
2. RECOMMEND the Award of Contract for the procurement of the **Repair/ Refurbishment of Broken Glass Windows and Replacement of Broken Bronze Glass in Various Offices at LRA CO Building**, in the amount of **THREE HUNDRED SIX THOUSAND AND ONE HUNDRED PESOS ONLY (Php 306,100.00)**.
