I. **The issues and concerns raised by the prospective bidders are as follows:**

JMD International Corporation

1. To inquire about the possibility of participating in the bidding of ITB - 100 sets of Colored Toner Cartridges for HP Laserjet PRO MFP M280NW Colored Printers identified under bid conference number 1112355. We understand that one of the requirements is to submit a certificate from the manufacturer confirming that the company is an authorized reseller of HP products or a dealer of genuine HP products.

ANSWER: The Committee affirms the submission of a certificate from the manufacturer confirming that the company is an authorized reseller of Colored Toner Cartridges. Such certificate must either be authenticated or certified as the true copy of the Certificate of Resellership that was granted by the manufacturer.
