**DECLARING 16/35 MM PRODUCTION SUPPLY AS THE LOWEST
CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND
DELIVERY OF TWO (2) UNITS OF HIGH-END MULTIMEDIA PROJECTORS**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee for Non-Infrastructure (LRA-BAC Non-Infra), pursuant to the provision of Republic Act No. 9184, specifically Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) which provides that the procuring entity may resort to **Small Value Procurement** (SVP) to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **Supply and Delivery of Two (2) Units of High-End Multimedia Projectors** with an ABC in the amount of **One Hundred Forty-Four Thousand Pesos Only (PHP 144,000.00), VAT Inclusive;**

WHEREAS, the said procurement was posted in the PhilGEPS and LRA websites on 28 May 2024;

WHEREAS, the Request for Quotation (RFQ) was sent to three (3) prospective suppliers;

WHEREAS, the deadline for submission of bids was on 04 June 2024, 04:00 PM, as specified in the RFQ;

WHEREAS, before the deadline, eleven (11) sealed envelopes from prospective suppliers were received by the LRA-BAC Non-Infra Secretariat;

WHEREAS, on 05 June 2024 at 9:00 AM, the eleven (11) sealed envelopes were opened and presented in a BAC Meeting called for the purpose;

WHEREAS, during the BAC meeting, the following results were obtained:

WHEREAS, **16/35 MM PRODUCTION SUPPLY** submitted the lowest quotation amounting to **Eighty-One Thousand Seven Hundred Sixty Pesos Only (PHP 81,760.00), VAT inclusive**, which is within the ABC;


WHEREAS, the offer of **16/35 MM PRODUCTION SUPPLY** is deemed to be the most advantageous to the government as the same is the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, the LRA-BAC Non-Infra finds the recommendation of the LRA-BAC Non-Infra TWG in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the LRA-BAC Non-Infra, hereby RESOLVE to:


- 1) DECLARE the quotation of **16/35 MM PRODUCTION SUPPLY** as the Lowest Calculated and Responsive Quotation (LCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the **Supply and Delivery of Two (2) Units of High-End Multimedia Projectors** to **16/35 MM PRODUCTION SUPPLY** with a submitted quotation price amounting to **Eighty-One Thousand Seven Hundred Sixty Pesos Only (PHP 81,760.00), VAT inclusive**.


