**DECLARING PROXIMATECH SOLUTIONS COMPANY AS THE LOWEST
CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND
DELIVERY OF FIVE HUNDRED (500) SETS OF ROLLS OF VELERON
STICKER WITH RESIN RIBBON**

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee for Non-Infrastructure (LRA-BAC Non-Infra), pursuant to the provision of Republic Act No. 9184, specifically Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) which provides that the procuring entity may resort to **Small Value Procurement (SVP)** to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **Supply and Delivery of Five Hundred (500) Sets of Rolls of Veleron Sticker with Resin Ribbon** with an ABC in the amount of **Six Hundred Fifty Thousand Pesos Only (Php 650,000.00), VAT Inclusive;**

WHEREAS, the said procurement was posted in the LRA website on 28 May 2024;

WHEREAS, the Request for Quotation (RFQ) was sent to three (3) prospective suppliers;

WHEREAS, the deadline for submission of bids was on 04 June 2024, 04:00 PM, as specified in the RFQ;

WHEREAS, before the deadline, five (5) sealed envelopes from prospective suppliers were received by the BAC-Secretariat for Non-Infra;

WHEREAS, on 05 June 2024 at 9:00 AM, the five(5) sealed envelopes were opened and presented in a BAC Meeting called for the purpose;

WHEREAS, during the BAC meeting, the following results were obtained:

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the LRA-BAC for Non-Infra, hereby RESOLVE to:

- 1) DECLARE the quotation of **Proximatech Solutions Company** as the Lowest Calculated and Responsive Quotation (LCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the **Supply and Delivery of Five Hundred (500) Sets of Rolls of Veleron Sticker with Resin Ribbon to Proximatech Solutions Company** with a submitted quotation price amounting to **Two Hundred Eighty-Five Thousand Pesos Only (Php 285,000.00)**, VAT inclusive.
