**DECLARING DEGTEK INFORMATION TECHNOLOGY SOLUTIONS AS THE
LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE
SUBSCRIPTION OF TWELVE (12) ZOOM APPLICATION LICENSES FOR ONE
(1) YEAR**

WHEREAS, the Land Registration Authority through the Bids and Awards Committee for Non-Infrastructure (LRA-BAC Non-Infra), pursuant to the provision of Republic Act (RA) No. 9184, as amended, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed Php 1,000,000.00, commenced the procurement for the **Subscription of Twelve (12) Zoom Application Licenses for One (1) Year** with an Approved Budget for the Contract (ABC) in the amount of **Two Hundred Thirty-Seven Thousand Nine Hundred Pesos Only (Php 237,900.00), VAT inclusive;**

WHEREAS, the said Request for Quotation (RFQ) was sent to at least three (3) prospective bidders and the same was posted at the LRA and the Philippine Government Electronic Procurement System (PhilGEPS) websites on 12 July 2024;

WHEREAS, before the deadline for submission of quotation lapsed on 18 July 2024 at 4:00 PM, four (4) sealed envelopes were received by the BAC-Secretariat for Non-Infra from the following prospective suppliers:

1. **DEGtek Information Technology Solutions;**
2. **Mybusybee Inc.;**
3. **Pronet Systems Integrated Network Solution Inc.;** and
4. **Challenge Systems Inc.**

WHEREAS, the four (4) sealed envelopes were consecutively opened and presented during the BAC meeting, called for the purpose, on 26 July 2024 at the LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, all four (4) prospective suppliers passed the eligibility requirements and the following results were obtained:

amounting to **Two Hundred Twenty-Five Thousand Six Hundred Thirty-Six Pesos Only (PHP 225,636.00) VAT Inclusive**, is deemed to be the most advantageous to the government as the same is the Lowest Calculated and Responsive Quotation (LCRQ);

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with RA No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR);

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the LRA-BAC Non-Infra, hereby RESOLVE to:

- 1) DECLARE the quotation of **Degtek Information Technology Solutions** as the Lowest Calculated and Responsive Quotation (LCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Procurement of **Subscription of Twelve (12) Zoom Application Licenses for One (1) Year** in the amount of **Two Hundred Twenty-Five Thousand Six Hundred Thirty-Six Pesos Only (PHP 225,636.00), VAT Inclusive**.
