SUBJECT : **BID BULLETIN 1**

FOR : **PROCUREMENT FOR THE SUPPLY AND DELIVERY OF PUBLIC ADDRESS SPEAKER SYSTEM**

This Bid Bulletin is hereby issued for the information and guidance of all prospective bidders relative to the submission of their respective proposals for the Supply and Delivery of Public Address Speaker System.

Any changes, revisions, modifications, or clarifications shall become an integral part of the Contract and Bidding Documents, and shall be taken into account in the submission of the prospective bidders' sealed proposals.

I. The issues and concerns raised by the prospective bidders are as follows:

Better Components, Inc.

1. Do you allow partial delivery?

ANSWER: Yes, partial delivery is allowed as long as within the required delivery period.

2. Are there further specifications of the item posted, like the power requirement and speaker woofer size?

ANSWER: The required wattage is 240 watts or its equivalent and the minimum size of the speaker is 32 cm x 68 cm x 36 cm.

Next Innovation Inc.

1. For the SLCC requirement, is it acceptable if the project is only related to, but not specifically for the supply and delivery of speakers?

ANSWER: As stated in Section III. Bid Data Sheet, the requirement for the Single Largest Completed Contract (SLCC) specifically refers to a similar category related to the 'Supply and Delivery of Public Address Speaker System' completed within two (2) years prior to the deadline for the submission and receipt of bids.

The Brain Computer Corp.

1. Is the 8hrs.playtime stated in the technical spec, pertains when battery operated?

ANSWER: With reference to the Technical Specifications, please be

informed that the indicated 8 hours playtime for the battery-operated device has been corrected. The correct specification is minimum of 12-hour battery life. This amendment supersedes the previously stated playtime and shall form part of the bidding documents.

2. May we know the minimum wattage and size of the speaker?

ANSWER: The required wattage is 240 watts or its equivalent and the minimum size of the speaker is 32 cm x 68 cm x 36 cm.


3. May we know the usage of the TWS, is it to connect to cellphone or earbuds?

ANSWER: TWS feature is intended primarily to allow wireless pairing between compatible speakers for stereo sound output.

II. LRA-BAC Non-Infra Reminders:

This Supplemental/Bid Bulletin No. 1 shall form part of the Bidding Documents and must be included in the submission of the Bid Proposal. Any provisions in the Bidding Documents inconsistent herewith are hereby amended, modified and superseded accordingly.
