(Pursuant to the Annual Procurement Plan Non-CSE for FY 2024)

**DECLARING INTEGRATED COMPUTER SYSTEMS, INC. AS THE LOWEST
CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND
DELIVERY OF TWELVE (12) UNITS OF BARCODE SCANNER**

WHEREAS, the Land Registration Authority through the Bids and Awards Committee for Non-Infrastructure (LRA-BAC Non-Infra), pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act (RA) No. 9184, as amended, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed One Million Pesos (Php 1,000,000.00), commenced the procurement for the **Supply and Delivery of Twelve (12) Units of Barcode Scanner** with an Approved Budget for the Contract (ABC) in the amount of **One Hundred Twenty Thousand Pesos Only (Php 120,000.00), VAT Inclusive;**

WHEREAS, the said Request for Quotation (RFQ) was sent to at least three (3) prospective bidders and the same was posted at the LRA and the Philippine Government Electronic Procurement System (PhilGEPS) websites on 16 November 2024;

WHEREAS, before the scheduled deadline for submission of quotation on 22 November 2024 at 4:00 PM lapsed, ten (10) sealed envelopes were received by the BAC-Secretariat for Non-Infrastructure from the following prospective suppliers: 1) **Bayan PC**, 2) **Newton Scanning Systems, Inc.**, 3) **Integrated Computer Systems, Inc.**, 4) **Audio4Design and Technology Corp.**, 5) **Competitive Card Solutions Phils., Inc.**, 6) **Printcore Office Systems, Inc.**, 7) **Triple RG Consumer Goods Trading**, 8) **Avtech Information Technology Solutions, Inc.**, 9) **ConnectWorks Company**, and 10) **Geoplan Philippines Inc.**;

WHEREAS, the ten (10) sealed envelopes were consecutively opened and presented during the BAC meeting called for the purpose on 28 November 2024 at the LRA Multi-Purpose Hall;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, only seven (7) of the ten (10) prospective suppliers have successfully met all the financial and technical specifications, namely: 1) **Newton Scanning Systems, Inc.**, 2) **Integrated Computer Systems, Inc.**, 3) **Audio4Design and Technology Corp.**, 4) **Competitive Card Solutions Phils., Inc.**, 5) **Printcore Office Systems, Inc.**, 6) **Triple RG Consumer Goods Trading**, 7) **Avtech Information Technology Solutions, Inc.**,

WHEREAS, the three (3) bidders were disqualified for the following reasons: Bayan PC failed to submit the original Notarized Omnibus Sworn Statement, ConnectWorks Company submitted an expired PhilGEPS

Registration Number, and Geoplan Philippines Inc. did not comply with the required technical specifications.

WHEREAS, the seven (7) qualified bidders submitted the following quotations:

WHEREAS, the LRA-BAC finds the recommendation of the BAC-TWG for Non-Infrastructure in strict compliance with Republic Act (RA) No. 9184, and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the LRA-BAC for Non-Infrastructure, hereby RESOLVE to:


- 1) DECLARE the quotation of **Integrated Computer Systems, Inc.** as the Lowest Calculated and Responsive Quotation (LCRQ); and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the **Supply and Delivery of Twelve (12) Units of Barcode Scanner** in the amount of **Fifty-Two Thousand Twenty Pesos Only (Php 52,020.00), VAT Inclusive**.


