DECLARING JEWEL CRAFTERS OPC AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY & DELIVERY OF GOLD RING FOR 45 YEARS IN SERVICE

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee (LRA-BAC), pursuant to the provision of Republic Act No. 9184, as amended, invited suppliers through sending the request for quotation to at least three (3) suppliers of known qualification for the Procurement of **Supply & Delivery of Gold Ring for 45 Years in Service**, via Small Value Procurement, with an ABC in the amount of **One Hundred Twelve Thousand Pesos (Php 112,000.00)**, VAT inclusive;

WHEREAS, before 08:00 AM, 23 January 2024 deadline, only one (1) sealed envelope from **Jewel Crafters OPC** was received by the BAC-Secretariat for Non-Infra;

WHEREAS, the quotation submitted by **Jewel Crafters OPC** was opened and presented during the LRA-BAC meeting, called for the purpose, on 23 January 2024, 9:00 AM at the LRA Finance Service Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, the quotation submitted by **Jewel Crafters OPC** was found to have full compliance with all technical specifications, as well as financial specifications;

WHEREAS, the single compliant bidder submitted the following quotation:

WHEREAS, Jewel Crafters OPC submitted the sole quotation amounting to **Ninety-Eight Thousand Pesos (Php 98,000.00)**, VAT inclusive, which is within the ABC.

RESOLVED this 23rd day of January 2024 at the Land Registration Authority, Quezon City.

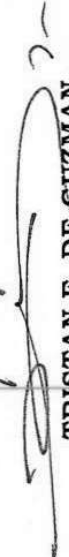
