LRA BAC NON-INFRA RESOLUTION NO. 2025-32

(Pursuant to Approved Annual Procurement Plan Non-CSE for FY 2025)

DECLARING INFOBAHN COMMUNICATIONS INC. AS THE SINGLE CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND DELIVERY OF MAINTENANCE RENEWAL OF FORTIGATE 200F UNIFIED THREAT MANAGEMENT BUNDLE FROM JUNE 8, 2025 TO JUNE 7, 2026

WHEREAS, the Land Registration Authority, through the Bids and Awards Committee for Non-Infrastructure (LRA BAC Non-Infra) , pursuant to the provision of Republic Act No. 9184, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed P1,000,000.00, commenced the procurement for the **Supply and Delivery of Maintenance Renewal of Fortigate 200F Unified Threat Management Bundle from June 8, 2025 to June 7, 2026 with an ABC in the amount of Four Hundred Ten Thousand Pesos (Php 410,000.00), VAT inclusive;**

WHEREAS, the said procurement was posted in the LRA and Philippine Government Electronic Procurement System (PhilGEPS) websites on 08 May 2025;

WHEREAS, Infobahn Communications, Inc., was the only bidder which submitted their quotation in a sealed envelope within the deadline set at 12:00 noon, on 14 May 2025;

WHEREAS, the sealed envelope was opened and presented during the LRA-BAC meeting called for the purpose, on 14 May, 2025 1:30pm at the 5th floor, Multi-Purpose hall, LRA Building;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra the lone bidder passed the eligibility and technical requirements. The offer of **Infobahn Communications, Inc.** amounting to **Two Hundred Sixty Eight Thousand Pesos (Php 268,000.00), VAT Inclusive**, is deemed to be the most advantageous to the government as the same is the Single Calculated and Responsive Quotation (SCRQ);

WHEREAS, the LRA-BAC Non-Infra finds the recommendation of the BAC-TWG for Non-Infra in strict compliance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations;

NOW, THEREFORE, We, the members of the LRA BAC Non-Infrastructure hereby **RESOLVE** to:



- 1) DECLARE the quotation of **Infobahn Communications, Inc.** as the **Single Calculated and Responsive Quotation (SCRQ)**; and
- 2) RECOMMEND to the Honorable Administrator the Award of Contract for the Procurement of **Supply and Delivery of Maintenance Renewal of Fortigate 200F Unified Threat Management Bundle** from **June 8, 2025 to June 7, 2026** with a submitted bid price in the amount of **Two Hundred Sixty Eight Thousand Pesos (268,000.00)**, VAT inclusive;
