WHEREAS, the three (3) sealed envelopes were consecutively opened and presented during the BAC meeting called for the purpose on 20 December 2024, 4:30 p.m. at 4th Floor, LRA Conference Room;

WHEREAS, per evaluation of the BAC-TWG for Non-Infra, all three (3) prospective suppliers have successfully met all the financial and technical specifications.
