DECLARING AVTECH INFORMATION TECHNOLOGY SOLUTIONS, INC. AS THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE SUPPLY AND DELIVERY OF 1-YEAR SUBSCRIPTION OF CREATIVE CLOUD ALL APPS FOR TEAMS LICENSES

WHEREAS, the Land Registration Authority through the Bids and Awards Committee for Non-Infrastructure (LRA-BAC Non-Infra), pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act (RA) No. 9184, as amended, which provides that the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the Approved Budget for the Contract (ABC) does not exceed One Million pesos only (Php 1,000,000.00), commenced the procurement for the Supply and Delivery of 1-Year Subscription of Creative Cloud All Apps for Teams Licenses with an Approved Budget for the Contract (ABC) in the amount of Two Hundred Twenty-Four Thousand Pesos and 01/100 (PHP 224,000.01), VAT Inclusive,

**WHEREAS**, a Request for Quotation (RFQ) was sent to at least three (3) prospective suppliers and the same were posted at the LRA and the Philippine Government Electronic Procurement System (PhilGEPS) websites on 05 October 2024;

WHEREAS, before the scheduled deadline for submission of quotation on 11 October 2024 at 4:00 PM lapsed, five (5) sealed envelopes were received by the BAC-Secretariat for Non-Infrastructure from the following prospective suppliers: 1) BayanPC Technologies, Inc., 2) Challenge Systems, Inc., 3) Ynzal Marketing Corporation, 4) Avtech Information Technology Solutions, Inc., and 5) Commerce First Inc.;

**WHEREAS**, the five (5) sealed envelopes were consecutively opened and presented during the BAC meeting called for the purpose on 14 October 2024 at the LRA 5th Floor Multi Purpose Hall;

**WHEREAS**, per evaluation of the BAC-TWG for Non-Infra, all five (5) prospective suppliers passed the eligibility requirements and the following results were obtained:
